

Jump Rope for Heart Self Donate \$35 or more 2026 Fundraising Promotion

Full terms and conditions

Details of Participation

- Promotion commences at 12:00am AEDT on Thursday 22 January 2026 and closes at 11:59pm AEST on Monday 23 November 2026.
- Information on how to enter forms part of these Details of Participation and entry is deemed as acceptance of them.
- Entries not received with these times and dates or not completed in accordance with the Details of Participation, will not be eligible.
- A “self-donation” refers to a contribution made directly by the student or their parent/guardian during the registration process, not by external sponsors.
- No purchase is necessary to enter the contest or redeem prizes.

Incentive details

- Eligible students will receive one (1) red handle skipping rope as part of this promotion.
- Limit of one skipping rope per student, regardless of the total amount donated beyond the \$35 minimum.
- If any prize is unavailable, the promoter reserves the right to substitute another item for the prize, in its sole discretion, of equal or higher value, subject to the approval of the relevant Government department.
- All prize values are correct at the time of printing.
- Prizes are not redeemable for cash unless otherwise indicated.

Eligibility

- The contest is open to Australian residents aged 18 years or more whose child is registered to participate in Jump Rope for Heart during 2026 and who raise funds through their online donation platform account.
- Employees and volunteers of the promoter and their immediate family members are not eligible to enter.
- Offline donations that are processed by teachers because of cash donations are not counted for entry.
- Offline donations that are processed by a parent via a child’s online donation platform account are eligible.

Donation requirements

- The qualifying donation must be processed successfully.
- Failed, reversed, or refunded donations will void eligibility for the incentive.
- Donations made through separate fundraising activities, do not count toward this offer.

Fulfillment

- Skipping rope will be distributed directly to the school for collection.
- Delivery timelines may vary based on stock availability, school distribution schedules, and postal delays.

- The organising body is not responsible for lost, stolen, or damaged items after delivery or distribution.
